Request for information from the Minister for Health and Social Services and the Deputy Minister for Health and Social Services from the Health, Social Care and Sport Committee to inform scrutiny of draft budget 2021-21

Commentary on Actions and detail of Budget Expenditure Line (BEL) allocations

- A breakdown of the 2020-21 Health and Social Services MEG allocations by Spending Programme Area, Action and Budget Expenditure Line (BEL).
- Indicative 2021-22 Health and Social Services MEG allocations.
- Commentary on each of the Actions within the Health and Social Services MEG, including an analysis and explanation of changes between the Draft Budget 2019–20 and the First Supplementary Budget (June 2019).

In addition to the four usual themes of value for money, prioritisation, preventative spending and affordability, the Committee would like to receive information on the following (where not already covered in the commentary on each Action):

Local health boards' financial performance

An update on the four health boards which have continued to fail to meet their financial duties, and how the Welsh Government is supporting them to improve this position.

Well-being of future generations

Evidence of how the Well-being of Future Generations Act 2015 and five ways of working have influenced the budget allocations for health and social care. The Committee is particularly interested in receiving details of how, going forward, the budget will:

- o prioritise prevention/early intervention in health and social care;
- support sustainable, longer term funding of social care services;

- o promote integration of health and social care services;
- o ensure a sustainable health and social care workforce;
- reduce and control spend on agency staff;
- o reduce health inequalities, and ensure fair access to health and care services in rural areas.

Transformation

- Further information about how the Welsh Government intends to fund service transformation in the longer term (i.e. beyond the life of the 2 year Transformation Fund), to ensure progress on the transformation agenda can be sustained.
- How will this budget support the development of a 'whole system approach' to health and social care, as described in *A Healthier Wales*.
- In setting its budget, how is the Welsh Government balancing the need to meet existing service pressures with the need to transform services and develop new models of care.

Primary care
